

## **LIFETIME DOG LICENSES**

All dogs three months of age or older must be licensed.

### **Procedure for obtaining a lifetime dog license:**

There are different procedures to follow for a tattoo lifetime license verses a microchip lifetime license.

\*Fill out the lifetime application. Somewhere at the top of the application indicate if you are using a tattoo or microchip for your license, as the application does not have an area to indicate your choice. See below for procedure.

**Tattoo:** Stop by the County Treasurers office to pick up the paper work needed for the lifetime license or send the application, payment and a self-addressed/stamped envelope to:

When the application, payment and self-addressed/stamped envelope are received the County will mail you the Permanent Identification Verification Form. This form has the number the Veterinarian will tattoo on the dog. When your procedure is done the Veterinarian will fill out and sign the appropriate area and return the form to you. You need to sign and date the Permanent Identification Verification Form and mail it or bring it to the Lebanon County Treasurer's office at which point the County will mail or give you the lifetime tag, which matches the tattoo number.

The dog must wear the license to be legal. If the tag gets lost, stop in or mail a request to the County at the address listed above along with a \$1.50 cash, check or money order payable to the Lebanon County Treasurer. PA State Dog Law will print you a new tag and mail it directly to you.

**Microchip:** If you have the Permanent Identification Verification Form that was filled out and given to you from your vet (you must also sign and date this form). Mail this form and the completed and signed Lifetime Dog Application along with appropriate payment. Or send a self-addresses/stamped envelope and request paper work to obtain a lifetime microchip dog license to:

The County will mail you a Permanent Identification Verification Form. You should fill out the top of the form. Take the form to your veterinarian and have him/her fill out and sign the appropriate area. The Veterinarian will return the form to you. You must sign and date the Permanent Identification Verification Form. Mail the Permanent Identification Verification Form, Application and payment to the address listed above. When the forms and payment are received the County will mail you a lifetime tag.

The dog must wear the license to be legal. If the tag gets lost, mail a request to the County at the address listed above along with a \$1.50 check or money order payable to the Lebanon County Treasurer. PA State Dog Law will print you a new tag and mail it directly to you.

**\*\*Keep in mind the Permanent Verification Form is only good for thirty days. You must have the form returned by the date indicated at the bottom of the form.**

**\*\*We only accept cash, check or money order. Do not mail cash. Make checks payable to: Lebanon County Treasurer.**
